# HIPE Coding Audit Toolkit<sup>®</sup>

The Hospital In-Patient Enquiry scheme is a computer-based health information system designed to collect clinical and administrative data on discharges and deaths from acute general hospitals in Ireland.

The HIPE Coding Audit Toolkit<sup>®</sup>, developed by the HIPE Unit of the ESRI, allows hospitals to conduct and report on chart based coding audits in a standardised format. This facility uses existing HIPE software to assess the quality of coding and reflect hospital activity accurately.

The HIPE Coding audit functions alongside the Windows HIPE (W-HIPE) software to enable efficient and consistent audit processes.

## HIPE Audit has the following benefits:

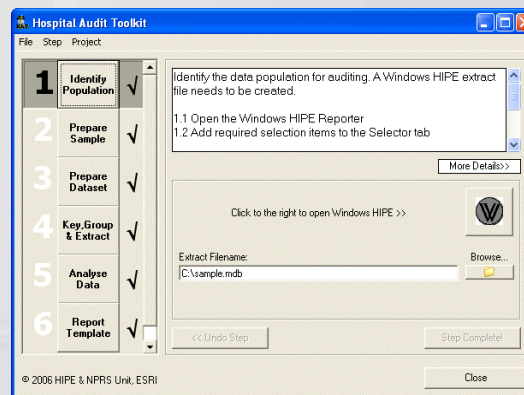
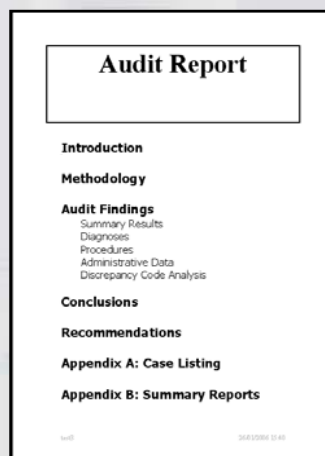

- ✓ Correction of errors in hospital data as appropriate



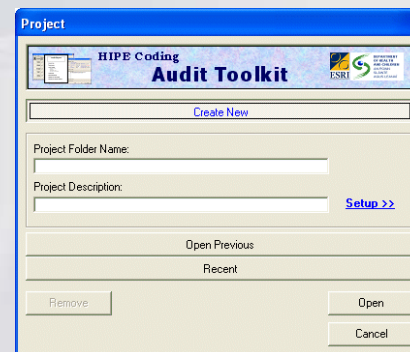
# Audit Steps Using the HCAT<sup>®</sup>

Audit Steps Facilitated by the HIPE Coding Audit Toolkit<sup>®</sup> (HCAT<sup>®</sup>):

1. Population Identification
2. Sample Preparation
3. Dataset Preparation
4. Keying, Grouping & Extracting
5. Case Analysis
6. Report Preparation



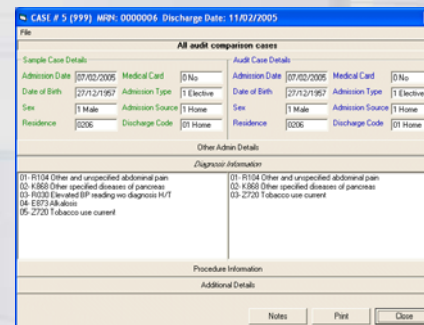

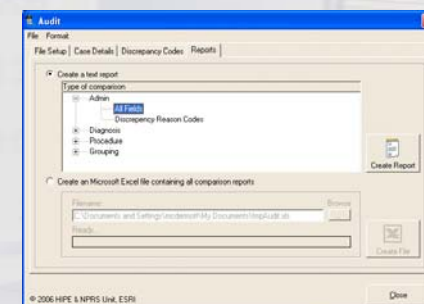
Audit Project Management
