THE ECONOMIC AND SOCIAL RESEARCH INSTITUTE

The Economic Research Institute was founded in Dublin in 1960, with the assistance of a grant from the Ford Foundation of New York. In 1966 the remit of the Institute was expanded to include social research, resulting in the Institute being renamed The Economic and Social Research Institute (ESRI). In 2010 the Institute entered into a strategic research alliance with Trinity College Dublin, while retaining its status as an independent research institute.

The ESRI is governed by an independent Council which acts as the Board of the Institute with responsibility for guaranteeing its independence and integrity. The Institute's research strategy is determined by the Council in association with the Director and staff. The research agenda seeks to contribute to three overarching and interconnected goals, namely, economic growth, social progress and environmental sustainability. The Institute's research is disseminated through international and national peer reviewed journals and books, in reports and books published directly by the Institute itself and in the Institute's working paper series. Researchers are responsible for the accuracy of their research. All ESRI books and reports are peer reviewed and these publications and the ESRI's working papers can be downloaded from the ESRI website at www.esri.ie

The Institute's research is funded from a variety of sources including: an annual grant-in-aid from the Irish Government; competitive research grants (both Irish and international); support for agreed programmes from government departments/agencies and commissioned research projects from public sector bodies. Sponsorship of the Institute's activities by Irish business and membership subscriptions provide a minor source of additional income.

Introduction

The ESRI celebrated its 50th year in 2010. Since 1960 there have been very significant changes in Ireland's economy and society, as we have moved through different economic cycles and adjusted to becoming a successful export-led economy. Some of the major challenges faced by Ireland today bear a strong similarity to those it faced in 1960, but with the added difficulty that today some of our greatest problems are of our own making. On the positive side, we have over those 50 years developed a greater entrepreneurial capacity and today we are well placed to face the global market place.

Over the past 50 years, the extent and breadth of the Institute's contribution to providing evidence for policy and its engagement with the Irish and European policy communities have expanded greatly. Research programme areas are relevant to Ireland's strategic policy goals in relation to economic growth, social progress and environmental sustainability. By expanding its remit to cover social as well as economic objectives in 1968, the Institute established itself at the interdisciplinary frontier between economics and sociology. This has allowed it to explore the economic implications of social policies and the social implications of economic policies.

From the outset, there has been a commitment to research excellence and the Institute has established a world class reputation for policy-relevant research in the social sciences. This reputation was underscored in 2010 by a peer review of the Institute's research, data-analysis and survey activities by a team of international and national experts. The peer review report, which is published on the ESRI website, also pointed to the need for the Institute to develop and consolidate some of its research programmes and to seek additional sources of funding that will allow it continue to produce high-quality independent research.

The ESRI's commitment to developing its role on the Irish research landscape was reflected in the creation of a strategic alliance with Trinity College Dublin (TCD) in relation to research in the social sciences. This alliance, which was formalised with the signing of a Memorandum of Understanding with TCD in July 2010, marks the Institute's new relationship with the higher education sector and its greater potential to engage in research projects and programmes that include disciplines outside the social sciences.

This Review of Research report is designed to give stakeholders and the wider public an overview of the research activities of the ESRI during 2010, which was another difficult year for Ireland as recovery from the crisis which hit the economy in 2008 proved slower than had been expected. Accordingly, the Institute updated its medium-term perspective for the economy, publishing Recovery Scenarios for Ireland – an Update in June 2010. The Quarterly Economic Commentaries continued to monitor and report on developments in the economy throughout the year.

National policy is currently strongly focused on immediate economic and social challenges, and the Institute's research agenda reflects these challenges. Research in microeconomics and in sociology is focused strongly on key areas of public expenditure (health, education, social welfare) and on major policy challenges (tax design, pensions, labour market activation, energy and environmental policy). However, it is important that we ensure that short-term actions do not undermine intermediate and long-term objectives. Major examples of research on longer term issues are the various longitudinal projects in which the Institute is currently involved: the Growing Up in Ireland project on children being led by the ESRI, the TILDA project on ageing being led by TCD, and the second-level education study being undertaken within the ESRI.

Introduction

Over the course of 2010, ESRI researchers published 59 journal articles and 11 book chapters, 38 reports and three economic commentaries. In addition, 30 working papers were released along with 14 research bulletins, which are published in the *Quarterly Economic Commentary*.

Researchers at the Institute routinely participate in expert groups invited to address national policies and key problem issues and are invited to become members of important national boards and committees. During 2010, such engagements included membership of the Mortgage Arrears and Personal Debt Group, the Central Bank Commission, the HSE Committee on Public/Private Mix in Consultant Contracts, and the Higher Education Authority. International bodies where ESRI researchers were involved included the US Expert Group on Climate Change Economics, the Northern Ireland Economic Advisory Group, OECD's SOPEMI Network on Migration and the UK's OFWAT Future Regulation Advisory Panel. Also during 2010, the Institute made an exceptional contribution to policy development in Ireland's health and social care policy, with the preparation of two substantive volumes of research evidence from nine different jurisdictions covering resource allocation, financing and sustainability.

To mark its 50th anniversary, the Institute held a series of conferences at which many of its major research projects were showcased. These conferences included: Environmental Policy and Protection; Poverty and Deprivation; Equality and Discrimination; Budget Perspectives; Resource Allocation; Financing and Sustainability in Health Care, Economic Policy Lessons from Ireland's Experience of Globalisation; Social Inclusion Policy; and Higher Education Policy. To mark the anniversary, there were two Geary Lectures, given by distinguished ESRI alumni: Professor Richard Breen, now at the Department of Sociology at Yale University, presented a lecture entitled *Social*

Mobility and Equality of Opportunity, and Professor Canice Prendergast, now at the University of Chicago Booth School of Business, presented a lecture entitled *Is Pay-For-Performance Effective?*




RESEARCH AREAS

The ESRI's research programmes are grouped under four general headings:

- research which is focused on informing policies related to Economic Growth
- research which seeks to inform policies relating to Social Progress
- research at the interface between Economic Growth and Social Progress
- research at the interface between Economic Growth and Environmental Sustainability

The following paragraphs summarise research activities and findings in these areas during 2010.

Economic Growth



There are two programmes of research in this area:

- Macroeconomics
 (coordinated by Professor John FitzGerald)
- Internationalisation and Competitiveness (previously International Economics and Technology, Innovation and Productivity) (coordinated by Dr Iulia Siedschlag)

MACROECONOMICS

Over the course of 2010 research was carried out on:

- (a) The macroeconomic effects of the crisis on the Irish economy. This research considered how the economy has been affected by the crisis and the possible paths to recovery. The results of this research were published in the *Quarterly Economic Commentaries* published over the course of the year. Using the *HERMES* model of the Irish economy, this research programme considered how different aspects of the economy were likely to behave in the medium term. The implications of this research for the Irish economy in the medium term were published in a study entitled *Recovery Scenarios for Ireland: an Update*.
- (b) Studies on the broader EU Economy and their Implications for Ireland. Research included a study on the effects on the EU economy of the increased migration resulting from EU enlargement, and a study of how the Spanish and Irish economies, and in particular the housing markets, were affected by EMU membership. This latter study drew conclusions on the appropriate use of fiscal policy. In December the ESRI, along with its colleagues in EUROFRAME, published a forecast for the Euro zone economy. Work continued on perceived inflation during the EURO changeover in 2002. In addition the preliminary results of work on the EU banking sector and recovery in the EU economy was released.

A major feature of the work of the ESRI on macroeconomics continues to be the development of key research infrastructure in the form of economic models. The HERMES macroeconomic model was built in the late 1980s and has undergone continuing development and improvement over the subsequent twenty years. It is a tool for understanding how the Irish economy behaves – what drives it and how it is likely to respond to changing circumstances at home and abroad. It is used for macroeconomic analysis and for exploring how macroeconomic developments may affect other aspects of the economy such as energy demand, environmental impact, skills needs and housing demand. Economic Growth

INTERNATIONALISATION AND COMPETITIVENESS

This research programme integrates two research areas, International Economics and Technology, Innovation & Productivity. This programme explores the links between international integration and technological change and their effects on productivity, competitiveness and economic growth. In 2010 research focused on five themes:

- (i) Economic Growth in Open Economies. This research, funded under the EU RTD 6th Framework Programme, examined the effect of human capital on the growth of industries intensive in information and communications technologies (ICT) using data from a sample of open economies over the period 1980-1999. The econometric analysis suggests that value added and employment in information ICT-intensive industries grew relatively faster in countries with a higher ex-ante human capital stock and in countries with a fast improvement in human capital. Further, in countries with fast human capital accumulation, labour productivity in ICT-intensive industries grew faster.
- (ii) Internationalisation of Services, Production and Growth. This research, funded under the EU RTD 7th Framework Programme, shows that larger firms, domestic exporters and firms closer to the global technology frontier were more likely to engage in R&D and innovation and were more likely to be successful in terms of innovation output. Further, the adoption of ICT was positively associated with innovation output. Co-operation with suppliers was positively associated with all innovation types, while knowledge flows from customers and from the government were positively linked to product innovation. In addition, co-operation with universities, as measured by patents, was positively linked to innovation.
- (iii) Foreign Direct Investment and Productivity
 Spillovers in the Irish Services Sector. This
 research, funded under a grant from the Irish
 Research Council for the Humanities and Social
 Sciences (IRCHSS), examines the presence of
 knowledge spillovers or competition effects from
 foreign-owned firms that affect the productivity

- of domestic firms. The results suggest that, at the level of the individual sector, foreign direct investment increases the productivity of domestic firms in some cases whereas in others it creates a more uncertain business environment.
- (iv) The Economic Impact of Information and Communication Technologies. Research on this theme, funded by the European Commission's Institute for Prospective Technological Studies, brought together the key findings and policy messages from the research on the knowledge economy, economic transformations and ICT in the European Union (EU). Key policy lessons identified included: the importance of a systemic and co-ordinated policy approach to develop the necessary structures and networks required by the interplay between ICT use, globalisation, regional innovation systems and regional economic performance; the importance of a long-term policy commitment combined with a certain degree of flexibility given the necessary learning, the nonlinear dynamics of the regional development process and rigidities which may delay necessary adjustment; the role of public policy in enabling structural change and sectoral diversification; the importance of fostering knowledge-spillovers and linkages between foreign and domestic firms; the importance of fostering intra- and inter-industry network effects and knowledge spillovers; the role of public procurement and e-government; the role of EU Structural Funds. This research suggests that an EU-wide "one-size-fits all" approach may not be best due to non-linear regional dynamics.
- (v) International Linkages, Innovation and Productivity. This research, supported by funding from the IRCHSS, shows that globalised firms (foreign-owned or domestic exporters) are most likely to invest in innovation, and to have successful innovations (product, process, and organisational innovations).



Social Progress



There are three programmes of research in the area of Social Progress:

- Equality
 (coordinated by Dr Helen Russell and Dr Frances McGinnity)
- Social Inclusion (coordinated by Dr Helen Russell)
- Health
 (coordinated by Professor Richard Layte and Professor Miriam M. Wiley)

EQUALITY

ESRI research on Equality investigates inequalities in opportunities and in outcomes, exploring the processes that lead to inequality. The research focuses particularly on assessing the role of public policies in underpinning or reducing inequalities.

In 2010 the ESRI was commissioned by **The Integration Centre** to develop a monitor to
measure the integration of immigrants in Ireland,
and publish an annual monitoring report on
integration. These indicators will allow researchers
to assess economic, political and social equality
of immigrants in Ireland. The first annual report
contains an overview of the main trends in
migration and chapters covering integration policy
and national indicators for employment, education,
social inclusion and active citizenship. The report
will be published in early 2011.

The integration of immigrants was also examined in a cross-national European project with colleagues from TCD. The project, entitled *Causes and Consequences of Early Socio-cultural Integration Processes Among New Immigrants in Europe (SCIP)* was funded under the **NORFACE** programme. The project studies integration trajectories of

new immigrants in Germany, the Netherlands, Ireland and Great Britain. Its substantive focus is on migrants' socio-cultural integration. Work on sample selection and questionnaire development was undertaken in 2010, fieldwork for Ireland, organised by the TCD research team, began in October 2010.

During 2010 work was completed on the research Programme on Equality and Discrimination, funded by the **Equality Authority**. The results from the research were showcased at an EU-funded conference Making Equality Count: Irish and International Approaches to Measuring Equality and Discrimination which was held in Dublin in June 2010. Papers were presented by current ESRI and former ESRI researchers, and by invited international speakers (Mary Gregory, Oxford University; Judy Rich, University of Southampton; William Darity, Duke University, USA). The papers presented at the conference were published in book form in November 2010. The edited volume provides an overview of the methodologies used to examine inequality and discrimination and presents the research results on the nature and causes of inequality in Ireland and elsewhere. A final

EQUALITY (continued)

research report on *Multiple Inequalities* is awaiting publication in 2011. The study examines the effects of belonging to more than one disadvantaged group across a range of outcomes. The study is based on the analysis of *Census 2006* microdata.

Work continued on a study of women's experiences in the workplace during and after pregnancy which was commissioned by the **Crisis Pregnancy Agency** and the **Equality Authority**. Final edits were completed on a review of

literature and on an analysis of the legal cases relating to Pregnancy Discrimination based on the caseloads of the Equality Tribunal, and the Labour Court over a nine year period. A research report based on the analysis of a national postal survey of women with young children; exploring experiences in employment during pregnancy (unfair treatment, health and safety, crisis pregnancy); experiences of maternity leave; decisions to return to work and working conditions on their return is due to be published in 2011.

SOCIAL INCLUSION

During 2010, researchers at the ESRI were involved in three major studies for the **Social Inclusion Division** at the **Department of Community**, **Equality and Gaeltacht Affairs:**

- (a) A report tracking the level and distribution of poverty in Ireland over the period of labour market expansion and increased welfare spending was published in September 2010. As well as describing trends for all households, the study focused on the experience of three life cycle groups: children, those of working age and older people. It assessed the influence of a range of key factors such as household composition, labour market position, social background and individual characteristics.
- (b) A study of financial exclusion and over-indebtedness in Irish households. The study was based on a special module of The European Union Statistics on Income and Living Conditions (EU SILC) carried out in 2008 and examined (i) the extent to which households have access to mainstream financial services such as a bank current account, credit and insurance, and (ii) the nature and causes of over-indebtedness in Ireland at the end of the economic boom and onset of recession. This study will be published in early 2011.
- (c) A Social Portrait of People with Disabilities. The study incorporated results from the National Disability Survey and the QNHS to provide a comprehensive statistical picture of the social and economic position of people with disabilities. The study was completed in 2010 and will be published in 2011.

Research on *The Impact of the "New Economy"* on the Labour Market, Inequality, Poverty and Well-Being in Ireland, funded by the Irish Research Council for the Humanities and Social Sciences (IRCHSS), was carried out in collaboration with UCD researchers.

Work was also completed on a series of EU level projects as part of the EQUALSOC networks.

Other comparative European research during 2010 included involvement in the European *GINI* project on increasing inequalities in income, wealth and education (with partners in UCD and across Europe), and a European project on minimum income, *The Evolution of Minimum Income Protection in the EU* (MIPI), involved the preparation of quantitative and qualitative information about Ireland for a European database aimed at the research community.

Two conferences were run jointly with the Social Inclusion Division as part of the European Year for Combating Poverty and Social Exclusion and the ESRI@50 celebrations. The first conference, Poverty in a European Perspective: Indicators, Findings and Policy Implications, was held at the ESRI in June. Minister Pat Carey launched the report Poverty and Deprivation in Ireland in a European Perspective which had been completed in 2009. A paper was presented on Living Conditions, Social Exclusion and Mental Well-Being in Europe based on the research study carried out for the European Foundation, and presentations were also made by Marco Mira d'Ercole of the OECD, and Olli Kangas, Research Department at the Social Security Institution of Finland.

A second conference, *The Use of Indicators and Targets in Social Inclusion Policy: National and European Perspectives*, held at the ESRI in November, was organised jointly by the ESRI, the Social Inclusion Division, and UCD Social Science Research Centre. Presentations were made by Olivier Bontout, Vice-Chair of the EU Indicators Subgroup of the Social Protection Committee, Jim Walsh, Social Inclusion Division, Brian Nolan, UCD, and Tim Callan, ESRI.

ESRI researchers also presented papers on the issues of poverty and social exclusion at a range of international conferences and seminars, for example at the final EQUALSOC conference that took place in Amsterdam on June 2010, and The Intergenerational Transmission of Inequality EQUALSOC workshop in Berlin, March 2010.

Social Progress

HEALTH

During the course of 2009-2010, a team of ESRI health economists provided research support to the Expert Group on Resource Allocation and Financing in Health Care, which was chaired by the Director and reported in July 2010. Two evidence volumes on Resource Allocation, Financing and Sustainability in Health Care reviewed the theoretical and empirical literature in eight comparator countries, evaluated the current Irish situation and proposed a framework for health-care entitlements and user fees that would support the delivery of integrated health care in Ireland.

The Sustainability of Irish Health Expenditure analysed trends in Irish public health expenditure, both over time and in comparative context, focusing particularly on public expenditure on pharmaceuticals.

A study on the *Cost of Stroke in Ireland*, commissioned by the **Irish Heart Foundation**, and involving the ESRI and the Royal College of Surgeons in Ireland, examined the total direct and indirect costs of treating and caring for stroke patients (new cases and stroke survivors) in Ireland in 2007.

Research on Potential and Actual Utilisation of Public and Private In-patient Beds in Irish Acute Public Hospitals examined the impact of public/private mix on in-patient bed utilisation in Irish acute public hospitals. It found that despite policies designed to limit private practice in Irish acute public hospitals, some hospitals have apparently been able to overcome restrictions.

A study on *Equity in Irish Health Care Financing: Measurement Issues* examined how international methods for measuring equity in health care financing underestimate the complexity of the Irish health care financing structures.

Research on the *Fall in Rates of Cardiovascular Mortality* in Ireland found it could be largely attributed to changes in prescribing patterns

following the implementation of the cardiovascular health strategy and the introduction of the medical card for over 70s. Related research on changes in perinatal mortality rates showed a decline over the past two decades in the differences in rates across social classes.

Other research showed that Alcohol Consumption contributes significantly to unintended pregnancy and the transmission of sexually transmitted infections (STIs). The study also showed that an individual's expectations about how they behave when drinking alcohol influence their behaviour over and above the effect of alcohol itself.

A study on *Parents' Perspectives on Parenting Styles and Disciplining Children*, commissioned by the **Department of Health and Children**, investigated parenting styles and parental use of disciplinary strategies with children in Ireland, with a particular focus on attitudes to and uses of physical punishment. The study found that most parents used inductive strategies (such as reasoning with the child). About one-quarter of parents interviewed had used physical punishment in the past year, this strategy was strongly influenced by the age of the child and the presence of behavioural difficulties in the child.

The European Foundation for the Improvement of Living and Working Conditions commissioned the Institute to research the relationship between living conditions, social exclusion and mental wellbeing, using data for 31 European countries.

The ESRI provided survey design consultancy on a number of national projects including the second round of the Irish Contraception and Crisis Pregnancy Survey.



EDUCATION

School organisation and process continued to be a key focus of the ESRI's educational research during 2010. The Post-Primary Longitudinal Study (PPLS), funded by the National Council for Curriculum and Assessment (NCCA) and the Department of Education and Skills (DES), continued throughout 2010. This study provided new insights into the processes shaping early school leaving in Ireland, revealing the complex interplay of school, family and individual characteristics, and also explored the transition to senior cycle and preparation for the Leaving Certificate examination.

A study of students taking the *Leaving Certificate Applied* (LCA) Programme, commissioned by the **NCCA**, examined the characteristics of young people who participated in the LCA programme approximately one decade after its introduction. It investigated their reasons for entering the programme, their learning experiences during LCA, and their subsequent employment and educational pathways, and represents an important evidence base for policy development.

Research on primary school design, commissioned by the **DES**, assessed how primary school buildings can be used to enhance the learning process. Other research on primary education, funded under the **EU FP7** project *Religious Education in a Multicultural Society* (REMC), explored the communication of religious and secular beliefs and values through the education system and the family and was part of a collaborative project involving University College Dublin as well as institutions in Belgium (Flanders), Germany, Malta, Scotland and Italy.

The first wave of a study of fourth-class primary school students, in partnership with an external fieldwork agency, was completed. This is part of a comparative international study of school effectiveness funded under the **EUROCORES** programme.

Research on young people's post-school transitions continued with a study, funded by 10 key educational organisations, examining the post-



school outcomes of young people who left school in 2007 and 2008, assessing the factors influencing their decision-making, their skills and competencies and their post-school pathways.

A study, commissioned by the Higher Education Authority (HEA), examined the experiences of young people from non-manual backgrounds in accessing Higher Education. The findings highlighted the role of school experiences, issues around information and advice, and financial constraints in shaping Higher Education entry for young people. Related research, also funded by the **HEA** on the *Costs of Participation in Higher* Education, explored the overall costs of attending college for students, placing a particular focus on the experiences of diverse groups with low rates of participation in Higher Education. Further research commissioned by the **HEA** examined the factors influencing student progression and retention once in Higher Education, and the factors shaping student success in Higher Education. The study demonstrated the importance of taking account of differences in the composition of student intakes in assessing institutional effectiveness.

LABOUR MARKET

Research on the labour market in 2010 focused mainly on three themes: unemployment and activation; the workplace; matching skills and jobs.

Following the publication of *National Profiling* of the Unemployed in Ireland in 2009, the **Department of Social Protection** began implementation of a national system of profiling and case management of unemployed clients in 2010, with technical assistance from the ESRI research team. Profiling is a state-of-theart statistically-based system for the early identification of those with a high probability of becoming long-term unemployed at the time they first become unemployed. It allows for a ranking of jobseeker claimants according to their likelihood of long-term unemployment, and provides the capacity to target resources on those who most need, and can benefit from, activation measures.

A follow-on project that involves combining the profiling data with administrative records of the National Employment Action Programme (NEAP) is evaluating the impact of the range of activation measures to assist unemployed individuals re-enter the workforce. The report on the impact of the NEAP is to be published in 2011. These research projects provide policymakers with essential information to inform the allocation and targeting of effective and appropriate programmes for the unemployed and are particularly relevant at a time of mass unemployment.

In 2010 work was completed on two workplace studies based on nationally representative surveys of employers and employees which were carried out in 2009 for the **National Centre for Partnership and Performance**. These surveys follow from the first national workplace surveys, carried out in 2003 in the midst of an economic boom. The research addressed a number of common themes, including:

- What is the impact of recession on the workplace and employees?
- Has the way work is organised changed?
 Have workplaces adopted 'high performance' workplace practices (HPWS)? Key aspects of HPWS are the devolution of decision making to employees (employee involvement), training and skill development in the workplace (human capital development) and working cooperatively in new ways.
- What are the workplace practices and employee characteristics that are associated with an openness to innovation and actual innovation in products and services?

Work continued on a major comparative international study on matching skills and jobs, in collaboration with researchers from Swansea University and Flinders University, Adelaide, on behalf of **Cedefop**, the European Centre for the Development of Vocational Training. During 2010 an extended literature and data review was undertaken which sought to identify the main findings of the international mismatch literature, the central questions that remained unanswered and the data constraints to effective future research. Further research utilised multiple waves of the European Working Conditions Survey to assess the extent to which skill mismatch and skill obsolescence was more prevalent among older workers and the degree to which differential impacts were observed with respect to key labour market variables such as earnings, job satisfaction, fear of job-loss and health.

DEMOGRAPHY AND MIGRATION

Given the changing economic circumstances which Ireland experienced between 2008 and 2010, it was inevitable that a change in emphasis would begin to emerge in the Institute's work on migration. Research, funded in part by the **OECD**, showed how severe the recession has been on immigrants, in terms of employment losses.


The issue of return migration and the wage advantages enjoyed by Irish workers with foreign experience of the local labour market were explored. As with earlier ESRI work on this topic, a wage advantage for returned migrants was again identified. Given the resumption in migratory outflows, this result is particularly important.

EMN Ireland, the Irish national contact point of the European Migration Network (EMN), is based at the ESRI. The EMN published four reports in 2010. The first provided an overview of migration and asylum trends and policy development in Ireland in 2009. The second explored assisted voluntary return of non-EU nationals, including comparative information on forced return and on assisted return scheme offered to nationals of EU-12 countries. The third report outlined the legal statuses in Ireland in respect of international protection subject to European law, and those that arise solely from Irish domestic law. The final report investigated Ireland's approach to satisfying labour market demand through migration in the period 2004-2010, with an emphasis on non-EU economic immigration, although information is also provided on EU immigration.

The ESRI also continues to be responsible for the Irish reports to SOPEMI, the OECD Continuous Reporting System on Migration, and a report based on 2009 data was produced.

Work began in 2010 on a study on immigrants and welfare receipt across Europe, commissioned by the **European Commission**. The Institute is working on this in partnership with the German research institute, IZA. The report will appear early in 2011.

Research in the ESRI on demographic matters will be facilitated in the coming years through the development of close ties with *The Irish Longitudinal Study on Ageing* (TILDA) in Trinity College. In March 2010, Alan Barrett took up a joint appointment between the ESRI and TILDA, where he began to work as Principal Investigator within the economics domain of the study.




SOCIAL COHESION AND QUALITY OF LIFE

ESRI research on the quality of life during 2010 explored the various domains of quality of life (health, family/relationships, work, economic) and the relationship between those domains, for example examining issues of work-life conflict, including its impact on the quality of life of children drawing on data from the *Growing Up in Ireland* Survey. Social cohesion research during 2010 focused on the issue of social participation, in particular participation in sport.

During 2010 the ESRI was involved in a number of studies that considered participation in sport and sports policy. The Irish Sports Monitor (ISM), funded by the Irish Sports Council, is an ongoing system for monitoring levels of participation in sport and exercise in Ireland with an annual sample of nearly 10,000 people. The annual report on the 2009 data, completed in 2010, will be published in 2011. The ISM data were also used to complete a study of participation in sport commissioned by **Dublin City Council** which was published in February 2010. This project helped to stimulate interest from other localities throughout the country. By end-2010, eight other regional reports on sport and exercise activity had been commissioned. Lastly, the "Sportfolio" project continued in 2010. It uses data on participation in sport from three separate sources to compile profiles of the most popular sport and exercise activities in Ireland.

Work continued on the design of a module for the fifth European Social Survey 2010 (ESS) on Work, Family and Well-being. The survey partially replicates the 2004 ESS module developed by researchers at the ESRI in collaboration with European partners. The module examines the implications of economic recession for family, work and well-being, including issues such as changes in the quality of work and their impact on work-family conflict, work pressure, and social integration. Data for up to 26 European countries will be available for analysis in 2011.

In conjunction with the School of Applied Social Sciences in UCD, the ESRI undertook a major study on changing family structures and fertility patterns in Ireland, funded by the Family Support Agency (FSA). This project was granted access to the 2006 Census Research Microdata File, allowing a more detailed analysis of family change in Ireland than has been possible to date. The final report was published early in 2010. A follow-on study was commissioned by the FSA to examine the extent to which partnerships are formed within and across social groups, the changing role of cohabitation, the possible causes of recent trends in fertility, and the primary living arrangements of children following marital breakdown. The project was initiated in 2010 and will be published in 2011.





TAXATION, WELFARE AND PENSIONS

Research in 2010 focused on a number of key areas for the tax and welfare response to the current economic crisis, including property taxation, the universal social charge and the distributive impact of policy responses to the crisis. The *SWITCH* taxbenefit model was used extensively to explore policy options and analyse policy choices. During the year the model was rebased to use information from the latest available CSO data (2008). The model was made available to the Departments of Finance and Social Protection, and training and support in model use was provided.

Key policy issues were examined in a number of publications, producing findings on the potential impact of possible changes to policy, and identifying the impacts of actual changes in policy. The potential role of a property tax was examined, paying particular attention to the issue of "ability to pay", which is one of the main objections raised to the introduction of such a tax. Analysis using SWITCH showed that an incomerelated waiver could help to address this issue, while still generating substantial revenue. The distributional impact of tax, welfare and public sector pay policies since 2009 (Budget 2009) was also examined. Overall this response was found to be progressive i.e., policy imposed greater reductions in net income on higher income groups over the period. There were differences over the period: responses during the years 2009 and 2010 were, for the most part, strongly progressive. The distributive impact of the response in Budget 2011 was broadly proportional – similar percentage changes across the main income groups.

Research undertaken in this area helped to inform public debate on tax and welfare policy issues. The *SWITCH* model was used in the preparation of *Budget 2011*, with analyses from the model supplied as part of the *Budget 2011* documentation. In addition, the model was used in the 'Review of Child Income Supports' completed by an interdepartmental group in December 2010.

Work on the modelling of pension policies continued, under a programme co-funded by the European Commission's Directorate-General for Employment, Social Affairs and Equal Opportunities. The work is being undertaken in collaboration with researchers at the National Institute of Economic and Social Research (NIESR). The aim of the project is to adapt and calibrate the model developed at NIESR in order to analyse policy issues in an Irish context.

A new project, updating the integrated network of tax-benefit models known as EUROMOD, was initiated, funded by the European Commission's Directorate-General for Employment, Social Affairs and Equal Opportunities. The skills of the Irish team are being used to allow a streamlined model of the Irish tax-benefit system to be constructed using data released by Eurostat from EU-SILC. This will allow comparative work on tax and welfare issues to be undertaken by Irish and international researchers.



ENERGY

A major feature of the work of the *Energy Policy Research Centre* (EPRC) has been the development of key research infrastructure in the form of economic models for research. These models are used as the basic tool in much of the work undertaken by the EPRC. Research during 2010 explored a wide range of issues.

In relation to energy demand, micro data from the *Census of Industrial Production* has been used to estimate elasticities of substitution between the inputs (capital, labour, energy) of manufacturing firms with the aim of assessing the response of manufacturing sector firms' energy use to changing prices and activity levels. This work helps assess the sectoral demand for fuels and will look in the future at the implications of a carbon tax. Initial results should be available later in 2011.

Work commenced on modelling the effects of increased investment in renewable electricity on investment incentives for other forms of generation. Related to this, work on the economic

implication of options to replace Moneypoint in 2025 is also under way. Related work has examined the REFIT scheme.

Other research looked at the determinants of electricity prices in Ireland and Great Britain, focusing on the extent to which they reflected long-run marginal cost and the appropriateness of retail prices in the different markets.

The ESRI worked with SEAI and other bodies in preparing official energy projections in the Autumn of 2010. The ESRI produced independent forecasts in relation to energy and the environment for the *Energy and Environment Review*. The *ISus* model has been developed to include a sub model of car ownership and utilisation, which represents a significant advance on the model used heretofore for forecasting energy demand. This revised model will be available for use in the Autumn 2011 forecasting process.

ENERGY (continued)

An energy model for Northern Ireland has been developed (*NiEMO*). This model can be used to forecast energy demand, including electricity demand, in Northern Ireland. It can also be used to examine the effects of some policy changes on the energy sector in Northern Ireland, in a similar manner to which the existing suite of models is used for Ireland. However, data and resource limitations mean that it is much less developed than *Idem-Hermes-ISus*.

Research also commenced on a review of the regulatory and related issues that are likely to arise as Ireland becomes part of the internal market in electricity through greater interconnection.

Work is under way (in collaboration with CER and assisted by ESB, BGÉ and others) on a major study of the costs and benefits of smart meters.



ENVIRONMENT AND NATURAL RESOURCES

Research this year in environmental and resource economics focused on four areas:

- Extending and improving our forecasting model for emissions to air, water and solid waste (ISus);
- Adding additional categories to our environmental accounts, including more detail on solid waste emissions and a range of persistent organic pollutants;
- Examining corporate expenditures on environmental protection in Ireland; and
- Climate policy.

Significant work was carried out on the follow-on study to the development of the *ISus* sustainable development model for the **Environmental Protection Agency** (EPA), *Towards Green Net National Accounts*. Developments to the model included improved modelling of the private car stock and housing stock, estimation of direct household emissions for several substances and the regional decomposition of emission forecasts. Some work was also undertaken into valuation

of environmental emissions and integration of these valuations into the model. The set of environmental accounts was extended this year to include a range of persistent organic pollutants and a more detailed set of solid waste categories and dispositions. The model was used to prepare an *Energy and Environment Review for Ireland*, which was published in December 2010. Earlier in the year, a report on Irish Waste Policy was published.

Using the *Census of Industrial Production*, the first industry-wide examination of Irish firms' expenditures on environmental protection was carried out, including both current and capital spending. Using the same dataset, work was undertaken on how energy inputs relate to industrial companies' productivity in Ireland. In the climate policy area, a diverse set of research questions were addressed, including further work on the determinants of vegetarianism in the UK and Ireland, a method for estimating historical landfill quantities when modelling methane emissions and the potential effects of climate change on civil conflict.

TRANSPORT AND INFRASTRUCTURE

Transport and infrastructure research in 2010 analysed a range of issues, including the determinants of commuting behaviour, the scale and impact of infrastructure investments and some management issues.

Research in relation to commuting explored issues around car ownership and mode choice, including the determinants of household car ownership over the period 1995 to 2001. This analysis showed that income and previous car ownership were the strongest determinants. The joint car ownership/mode choice decision was found to depend significantly on the availability of rail, the home-work locations, travel costs, and individual characteristics.

Models of the car stock, its composition and use were developed and used for the analysis of changes to the taxation regime pertaining to car purchases, ownership and fuel. Research showed that the reform of the vehicle registration and motor tax regime has led to a dramatic shift from petrol to diesel cars. The tax burden has shifted from car ownership to car use, but the overall tax burden on private car transport has fallen. Consequently, the implications for the exchequer are that the changed regime has resulted in a considerable loss of revenue. Furthermore, the cost of avoided carbon dioxide is relatively high.

Analysis of 'Metro North' applying two alternative methods to the conventional cost-benefit analysis found these methods to yield conflicting results regarding the net benefit of going ahead with this project. This analysis highlights the need for further study of this project.

Research constructing regional government accounts for the first time computed regional gross fixed capital formation by broad investment type. This showed that while Dublin receives a significant proportion of public infrastructure investment, in per capita terms the level of investment is not disproportional.

Other research explored the history of the LUAS project, the reasons for not connecting the two lines and the feasibility of alternative links between the lines, as well as progress on integrated ticketing (highlighting the exceptionally long delay in introducing integrated ticketing). Finally, an analysis of the cuts to the public capital programme showed that not only were the cuts very significant, but that the cuts appear to have been differentiated broadly on the basis of potential economic impacts of the expenditure.

COMPETITION AND REGULATION

Research on competition and regulation concentrates on energy, the environment and electronic communications, with attention also being paid to a number of cross-sectoral issues such as the governance of regulators and the sale of state assets.

The impact and implications of the move towards the creation of an internal European Union electricity market is being studied, building on the extensive research conducted at the Institute in this area. A submission was made in response to the Commission for Energy Regulation's *Proposals on a Roadmap for Deregulation* of price control of retail electricity.

In relation to the environment, *An Economic Approach to Municipal Waste Management Policy in Ireland* was published early in 2010, report prepared for Dublin City Council. Building on the research underlying this publication, a submission was prepared in response to the Department of the Environment, Heritage and Local Government's Draft Statement of Waste Policy.

During 2010 funding for a programme of research in communications was secured. This will address four broad research topics:

- 1. Modelling the market for broadband services;
- 2. Economic and social aspects of broadband availability and adoption;
- 3. Effects of electronic communications services on company performance;
- 4. Implications of behavioural economics for economic regulation and consumer protection.

Research was completed on the timing and determinants of local residential broadband adoption in Ireland and on the effects of computer and internet use on educational outcomes of primary school children. Work was also completed on a report for the UK Communications Consumer

Panel on behavioural economics and vulnerable consumers.

In terms of issues that cut across regulated sectors, a paper was prepared on the October 2009 Government Statement on Economic Regulation, which marks a significant change in the governance of the regulators in energy, transport, telecommunications and aviation. In contrast to some jurisdictions, state-owned assets are still of substantial importance in Ireland. A submission was made to the Review Group of State Assets and Liabilities as to appropriate public policy towards the sale of such assets in troubled economic times.

Finally, research continued to monitor the economic analysis presented in Irish court decisions in competition cases, including a study of the Panda Waste case in which the High Court concluded that the practice of using competitive tendering as the model to collect household waste was a breach of competition law.

During 2010, work continued on the major sevenyear research programme involving a national longitudinal study of children – the *Growing Up in Ireland* study. This programme is being led jointly by the ESRI and Trinity College, Dublin in collaboration with a consortium of researchers from other national and international universities and research institutions.

Following a Pilot and Dress Rehearsal, the main fieldwork for the Infant Cohort (at 3 years) began in December. The families of the 11,000 children who were interviewed when the infants were nine months will be surveyed.

Pilot work was also carried out with the 8,500 children in the older cohort who, with their families, were initially interviewed when they were 9 years of age. These children and their families will be re-interviewed at 13 years of age in 2011.

Data from the 9-year cohort were made available in the Irish Social Science Data Archive (ISSDA)¹ in May. This allows researchers to access anonymised data from the first round of interviews with the older cohort. Data workshops on the archived data were held through the Summer and Autumn.

The second annual *Growing Up in Ireland* research conference was held in November, with a Keynote address from Professor Anne Sanson, Professor in Paediatrics at the University of Melbourne and the

Surveys and Data from Administrative Records

The Health Service Executive funds the ESRI to manage and develop two national data bases collecting health information from administrative records. During 2010 reports on the Hospital In-Patient Enquiry (HIPE) and the National Perinatal Information System (NPRS) were published and can be accessed on the ESRI website (www.esri.ie). These annual reports provide easily accessible and timely data for individuals or organisations with an interest in perinatal statistics and hospital discharge data. The HIPE Data Reporter facilitates direct access to HIPE data via the internet.


The clinical coding training programmes delivered during the year provided training to over 500 participants. Distance training using a WebEx facility was introduced to enable increased attendance at these courses and reduce travel time and the associated expense. WebEx and face to face training was also provided to over 300 participants for the new HIPE Portal. The HIPE Portal is a customised web based software package developed, maintained and supported by the Health Research & Information Division (HRID) for data entry and reporting of HIPE data in participating hospitals.

There was extensive engagement and collaboration with some of the HSE clinical care teams who are planning to use the HIPE and NPRS systems within the respective programmes. Training in the HIPE system, and particularly clinical coding and data analysis are provided to these teams on request.

Presentations on data collected by the HIPE system were delivered at a number of conferences throughout the year. The ESRI conference on 'The Irish Healthcare System: Resource Allocation, Financing and Sustainability' involved a number of presentations from researchers who had been involved in the preparation of the two evidence volumes which were published in association with the Report of the Expert Group on Resource Allocation and Financing in the Health Sector.

Presentations were also delivered at the Nordic DRG Conference and the International Society for Quality in Health Care (ISQUA) conference in Paris where there was a presentation and poster

presentation on HIPE data quality. For the Patient Classification System International conference in Munich there was a review of developments with the use of the ICD-10-AM and AR-DRG systems in Ireland while the presentation at the International Federation of Health Records Organisations (IFHRO) congress reported on a project undertaken to assess the potential for accreditation of the ESRI's clinical coding training programmes.
