### **Industry Challenges**

- Increase in Cybercrime
- Geopolitical tensions (Iran, North Korea using Cyber as an attack vector)
- Increasing regulatory mandates (GDPR, CCPA etc)
- Increasing network complexity
- Lack of skills in the market estimated 2 million job vacancies

## **Success in Cork**

14 Startup Companies participated across 3 Accelerator Programmes

- 14 companies participated from 8 countries (India, HK, Ukraine, USA, Spain, Bolivia, UK) . 6 were Irish promoter-based companies and 11 out of 14 set up an Irish HQ
- €4.8 million of third-party equity seed capital has been invested into 5 of these participating companies
- 100 direct / 250 indirect jobs created

Companies who have participated in the programme are now valued at €38 million on paper with a 3.5x increase on their original value after 1 to 2 years

# **Visa and Entry issues**

- 14 companies participated from 8 countries (India, HK, Ukraine, USA, Spain, Bolivia, UK, Ireland).
- **2018** -no way for Indian applicants to get a long stay multi –entry visa without 2 single entry Short Stay 90 day visas. Alt was the UK and the BIVS scheme. LOST ONE PARTICIPANT at the end of the cohort 2.
- High tech visas fell between Education and Corporate hire/transfer
- 2019 DoJE introduced the Start Up Entrepreneur Programme (STEP) giving 12-24 months multi-entry. The 90 day Short Stay Employment visa still applied to be upgraded on arrival to a STEP visa in 3-8
