#### **ALAN BARRETT**

is the CEO of the Economic and Social Research Institute, Ireland's leading centre for policyoriented social science research. He holds a Ph.D. in Economics from Michigan State University. He is currently a member of the Northern Ireland Fiscal Council, an honorary member of the Society of Actuaries in Ireland, a member of the Royal Irish Academy and an adjunct professor at TCD. He was a member of the Irish Fiscal Advisory Council from 2011-2015.



#### **HUGH BRENNAN**

has worked in construction for the past 40 years. In 2003 he became involved, initially as a volunteer, in humanitarian aid work oversees and then working full-time with the Township Trust in South Africa. From 2011 to 2013 Hugh worked in post-disaster reconstruction with the International Federation of the Red Cross (IFRC) in Haiti. When he returned to Ireland, he set about creating a model to deliver affordable homes based on cohousing models. In 2014 he co-founded Ó Cualann Cohousing Alliance.



## **DR MICHAEL BYRNE**

is a lecturer in Social Policy, Social Work and Social Justice (UCD) and the Director of the Equality Studies MSc. His research focuses on the political economy of the private rental sector. In 2020 he co-authored Threshold's report Security and Agency in the Irish Private Rental Sector. Recent publications include Stay Home: Reflections on the meaning of home and the Covid-19 pandemic (Irish Journal of Sociology), Institutional Investment in the private rental sector in the wake of the Covid-19 pandemic (Geary Public Policy Institute), and The impact of Covid-19 on the private rental sector (Geary Public Policy Institute).



#### **TOM DUNNE**

is the Chairperson of the Residential Tenancies Board (RTB), Fellow of the Society of Chartered Surveyors Ireland and former Head of the School of Surveying & Construction Management, TU Dublin.

His main role now as part of CaCHE's Knowledge Exchange Team - a role that seeks to provide a bridge between the academic world and the housing sector in Northern Ireland.



## **DR AIDEEN HAYDEN**

is Chairperson of Threshold and a qualified solicitor, with a degree in Economics and History and a PhD in social policy from UCD where she was awarded an Ad Astra Scholarship. Aideen has worked in the field of housing for over two decades. Her key achievements as Chairperson of Threshold have included leading the campaign to improve security of tenure for tenants in Ireland which ultimately resulted in the introduction of the Residential Tenancies Act 2004 and the establishment of the Tenancy Protection Service. Aideen has published a number of reports including a report on the Future of Council Housing with Professor Michelle Norris (2018) and on mixed tenure developments, Rebuilding the Irish Neighbourhood with Bob Jordan (2019). She continues to work for a fairer housing system and aright to housing for all.

## **DR MARTINA MCAULEY**
