

### THE ECONOMIC & SOCIAL RESEARCH INSTITUTE

The Economic and Social Research Institute is a non-profit organisation which was founded in 1960 as the Economic Research Institute with the help of a grant from the Ford Foundation of New York. In 1966, following a report by a United Nations special adviser, the Institute assumed responsibility for social research and extended its title to The Economic and Social Research Institute.

The Institute is a private company, limited by guarantee, incorporated under the Companies Acts 1908-1990, and enjoys full academic independence. It is governed by a Council consisting of 30 members, in addition to the President and the Director, appointed from the general members of the Institute and representative of business, trade unions, government departments, state agencies, universities and other research institutes. A committee of the Council, the Executive Committee, carries out the functions of the Institute's Board of Directors.

The Institute receives an annual grant-in-aid from the Irish Government which, in 1997, covered approximately 34 per cent of total expenditure. The remainder of its income is generated from commissioned research projects, sponsorship of Institute activities by Irish business, membership subscriptions and sales of publications. The most important resource of the Institute is its high-quality staff with the requisite academic standards, training and expertise. The total number of full-time research staff at the Institute is 36. The results of the Institute's research have been included in over 500 published reports, in addition to the volumes of the *Quarterly Economic Commentary* and the *Medium-term Review of the Irish Economy*, as well as in numerous books, articles in academic journals, etc., published elsewhere.

#### THE ECONOMIC & SOCIAL RESEARCH INSTITUTE

The Medium Term Review published in April of 1997 emphasised the depth and speed of the transformation taking place in Ireland's economy and society. National income has grown at an exceptional rate since 1993 and seems set on an improved trajectory throughout the next decade. Growth is reasonably balanced and the prospects for a sustained reduction in unemployment appear good. A favourable demographic situation combined with this rapid income growth will allow a considerable reduction in the level of national debt. Entry into EMU will offer new opportunities but will also impose new disciplines and necessitate the re-thinking of old attitudes and patterns of behaviour.

### **FOREWORD**

In this context, ESRI research has focused on how the beneficial aspects of change can be fostered and possible dangers avoided. The *Quarterly Economic Commentary* continued to point out the shifts in attitudes needed to deal with the prolonged success of the Irish economy and the imminence of EMU in relation to issues such as inflation, wage determination and taxation. The *Medium Term Review* drew attention to the dangers posed by excessive expectations, congestion and inflexibility in the face of external economic shocks.

Environmental concerns are likely to be re-enforced in a period of rapid change. The Institute has in hand a number of projects devoted to this area. During 1997, ESRI staff produced a major book entitled *The Fiscal System and the Polluter Pays Principle* which demonstrates the potential of economic instruments (such as green taxes and subsidies) to effect environmental improvements. The critical policy choices involved in limiting greenhouse gas emissions and the likely costs were also analysed and formed the theme of a Conference.

The Irish labour market is also being transformed and policy must adapt accordingly. ESRI research in 1997 ranged across many aspects of the changing labour market. Trends in school leavers' employment experiences were documented. Detailed occupational forecasts were produced which analysed the nature of the changes taking place and identified the types of skill likely to be in high demand. Commissioner Flynn launched an important study on active labour market policy in the Institute in September. This study broke new ground by casting new light on why certain types of scheme worked while others did not. Work also proceeded on how the educational system can be made more effective in fulfilling its many objectives.

Improved growth also opens up possibilities to improve the situation of the disadvantaged. The Institute has a major programme of work based on on-going household surveys which examine in depth issues related to poverty, deprivation and unemployment. During 1997, major studies were completed in relation to low pay, income support and work incentives, the elderly and the welfare implications of demographic trends. A Conference was held in January 1997 at which estimates of poverty rates in the 1990s were presented together with an analysis of minimum adequate income levels. Work continued on SWITCH the microsimulation model which allows users to assess the implications of changes in tax and social welfare policies.

In order to pursue a work programme of this breadth and relevance, it is necessary for the Institute to pursue research at a number of different levels, ranging from basic developmental work to the analysis of urgent policy concerns. Some of this work can be funded through commissions. However, it is often difficult to find resources for research into the longer term and more strategic issues, even though such analysis is vital to a full understanding of the more immediate policy problems. For this reason, the Institute particularly appreciates the part played in our work by the Government grant-in-aid and by the untied contributions of those firms and organisations which subscribed to the recent fund-raising campaign.

### REPORT OF THE COUNCIL

#### INTRODUCTION

During 1997, eighteen substantive reports were published either by the Institute or by outside organisations, in addition to papers presented at conferences and seminars, working papers and journal articles. In addition, thirty six commissioned reports were completed and twelve surveys were undertaken for outside organisations.

Major research studies were completed during the year in the following areas:

- Economic forecasting: short- and mediumterm;
- EU structural funds in Ireland;
- Industrial development including competitive advantage;
- Development of small and medium sized enterprises (SMEs) in a European context;
- Compilation of regional GDP;
- Global warming and the costs of greenhouse gas abatement;
- The environment including the fiscal system and the polluter pays principle;
- European approaches to environmental issues;
- Water based leisure activities;
- Aspects of the economic and policy impacts of EMU including the case of Northern Ireland and exchange rates and interest rates;
- The effects of internationalisation of the EU Banking system on periphery countries;
- The effects of the Single European Market (SEM) on peripheral countries;
- Income distribution and social protection;
- Income support and work incentives;
- Pension arrangements in the Civil Service and the public sector;
- Low pay in Ireland;
- Occupational employment forecasts;

- Active Labour market policy;
- Economic status of school leavers;
- Review of graduate employment trends;
- Transitions in youth;
- Health issues including surgical audit in hospitals and hospital financing in the EU;
- Welfare implications of demographic trends;
- The elderly, the family and the state;
- Poverty, minimum adequate income and poor households;
- Roy Geary his life and work.

Five very successful conferences/symposiums were organised by the Institute during 1997 as follows:

- ♦ A conference on "Poverty and Income Adequacy: First Results from the 1994 Living in Ireland Survey" (January, 1997) presented an overview of the survey, detailed the level of poverty in Ireland in the 1990s and reviewed and updated the Commission on Social Welfare's recommendations on a Minimum Adequate Income.
- In January 1997 a symposium was organised by the Historical National Accounts Group at the ESRI. Papers were presented on prices, wages and living standards in Ireland 1700-1850, the development of national accounts methodology in Irish official statistical and monetary data and proxy GDP estimates for Ireland 1840-1921.
- A conference on "The Environment and EU Treaty Revisions: The IGC Review" (March organised by the ESRI 1997) was Environment Policy Research Centre in association with the Institute of European Affairs. The conference addressed the issues arising from the revision of the Treaty of Maastricht. Irish speakers at the conference described the amendments proposed in the Irish draft treaty particularly in regard to sustainable development and the problem of giving substance to the "polluter pays principle". International speakers from the Netherlands and the UK discussed the proposed changes to the treaty. The lack of a firm legal basis was seen as the main problem in the treaty as well as the absence of reference to sustainable development and to the integration of environmental policy in all EU policies.
- ♦ A conference on "Public Service Pensions Policy Issues" (September 1997) was

organised by the Institute in association with the European Network for Research on Supplementary Pensions. Papers presented by an international panel of speakers covered issues on public service pension arrangements, demographic projections and population ageing and government regulation of public service pensions. The funding and reform of public service pensions, including the question of privatisation, were also considered.

♦ In November 1997 a conference on "The Economic Implications of Greenhouse Gas Abatement" was held under the auspices of the ESRI Energy Policy Research Centre. The papers presented dealt with energy demand in Ireland, future emissions of greenhouse gases, the cost of abatement and the international approach to tackling global warming.

During 1997, twenty seven new research projects were commenced by the staff of the Institute in the following areas:

- (i) Economic Forecasting: Ireland's regional GDP;
- (ii) Economic Growth: impacts of European Monetary Union (EMU) on Northern Ireland; agricultural schemes and premia payments; preferences and attitudes to forest development; North-South economic co-operation;
- (iii) Environment: impact of continuing transport growth; limitation and reduction of CO<sub>2</sub> and greenhouse gas emissions; compilation of satellite environmental accounts; energy efficiency investment programmes;
- (iv) International Environment: structural change in transition economies; the role and impact of the CSF, objective 1 regions, the German experience;
- (v) Prices and Incomes: low pay in Ireland;
- (vi) Demography and Labour: returns to continuing vocational training; replacement rates; occupational forecasts; labour market transitions; employment in Gaeltacht areas;
- (vii) Social Policy: distribution of income and earnings; women and poverty; living standards and household composition; child poverty; drug abuse; urban local authority housing estates;
- (viii) Education: strategic plan for regional technical college; educational policy for disadvantaged children;
- (ix) Health: health promotion and disease prevention; data quality of Hospital In-Patient Enquiry (HIPE).



By the end of 1997 fifty-two major research projects were in progress at the Institute. Further details of ESRI research, publications and new projects are given in a companion volume of the Annual Report entitled *Review of ESRI Research* 1997.

#### **ESRI RESEARCH**

After its establishment in 1960, the Institute soon became the dominant centre in Ireland for social science research. Over the years this dominance has moderated due to the considerable increase in the number of social science staff in the Irish universities and other third level institutions, as well as in other organisations in the public and private sectors. The Institute welcomed this growth in Irish social science research. and has, indeed, contributed substantially to it, not least through its fellowship scheme for post-graduate studies overseas in the areas of economics and the other social sciences. Of the beneficiaries of this scheme - over 130 fellowships to date - in excess of 70 per cent have returned to Ireland to take up positions in third level institutions, in the civil and public services, in the private sector and in the Institute itself.

In the light of this growth in national research effort, it is useful to re-state how the Institute sees its particular role. Social science research may be viewed as a spectrum running from the most abstract pure research through applied work to the provision of up-to-date management information. Pure research is focused on the development of the discipline and concentrates on theory and methodology. preferred publication medium is the international journal and its target audience is other specialists. At the other end of the continuum, management information emphasises the provision of quick and relevant results to policymakers, leaving little scope for in-depth analysis. The type of research carried out by the ESRI lies between these two extremes. It tries to balance the needs of users of research with the requirement to meet those needs at a high level of quality and objectivity. The Institute aims to apply the latest thinking in the social sciences to the current and prospective problems of Ireland's economy and society.

To achieve this, the research programme needs to encompass three interdependent types of work:

 the development of the methods, models and databases necessary to facilitate in-depth analysis of economic and social issues;

- strategic medium- to long-term studies essential for planning economic and social development;
- the application of methods and established knowledge to resolve shorter-term problems
   and to undertake current assessments and evaluations.

Basic Research: the long-tem investment of resources in basic research (i.e., work on theoretical development, methodology and the creation of models and databases) forms the essential basis of the research programme. instance, the sophisticated macro-economic models developed at the Institute over the past fifteen years have underpinned a variety of studies of the economy, including comparisons of the two economies of the island of Ireland and work on peripheral economies in the EU. Similarly, the major household surveys carried out in 1987 and in the years since 1994 have led to a stream of influential research on a wide variety of topics: unemployment and the labour market; work incentives; poverty and income distribution; taxation and social protection policies; the health services; education; pensions etc. They also permitted the development and updating of SWITCH, the ESRI's microsimulation model for the assessment of tax and welfare policies. Other initiatives include the creation, collaboration with FAS, of a system for projecting the national occupational structure and the compilation of extensive national databases related to health issues (the HIPE system).

Strategic Research: a considerable portion of the Institute's programme of research, is devoted to strategic research to underpin the development of economic and social policy. The publication of the ESRI Medium Term Review (1997) is a prime example of this type of research as is the 1996 report on the Implications for Ireland of EMU. examples include the Institute's participation as the Irish representative in the European observatory for small and medium-sized enterprises, studies of industrial competitiveness, research on income distribution, social mobility and poverty and much of the research in hand in the areas of vocational training, labour market transitions and education.

Applied Research: The remainder of the Institute's resources is directed towards obtaining and publishing new knowledge on specific issues of direct policy relevance. Studies of this kind crop up in all areas of Institute's research programme. They include, for example, the

examination of current trends in the Irish economy, analyses of energy data and greenhouse gas emissions, the role and impact of the CSF, bank credit and bank resources, the impact of incompany training, investment in human capital, the effectiveness of the social welfare system, studies of the family, society and the state in Ireland etc.

The accelerating pace of change, and the growing globalisation of economic relationships, mean that research of the kind conducted by the ESRI is essential for rational policy making. In order to guarantee the relevance and effectiveness of its work, the Institute has increasingly engaged in various types of partnership arrangements at both national and international level. Such partnerships include collaboration with the public and the private sectors, and with both funding organisations and other research bodies.

Collaboration at National Level: the Institute sees its work as essential to the work of Government and State Agencies responsible for the development and implementation of policy. Working relationships have been developed with a number of such departments and agencies, most notably the Departments of Enterprise, Trade and Employment, Education and Science, Health and Children, Social, Community and Family Affairs and the Central Statistics Office and agencies such as FÁS (The Training and Employment Authority), the National Economic and Social Council (NESC), the Combat Poverty Agency, Forbairt, Forfás and the National Economic and Social Forum (NESF).

The Institute has received considerable support from the Irish business community over through corporate vears expressed membership of the organisation, its response to the Institute's fund-raising campaigns and its direct support for research programmes in operation at the Institute. Irish business finds particular value in the detailed and independent analyses of the Irish economy provided by the Quarterly Economic Commentary, the Medium Term Review and the various studies in areas such as banking and finance, competitiveness of industry, energy, the environment and the labour market. Institute staff have also been readily available to members of the business world for debate and discussion on various issues. Business firms require in-depth evaluations of the economy in which they operate, how it is performing and its future prospects and they appreciate briefing by experts of established independence.

For a number of years, and particularly since 1991, the Institute has been engaged in major research projects on the two economies of Ireland - North and South. Both economies have many similarities, not least in the difficulties which them for decades in regard unemployment, emigration, public finances, the development of indigenous industry etc. The research has been undertaken under the aegis of the International Fund for Ireland (1992-1994), the Forum for Peace and Reconciliation (1995-1996), the General Consumer Council for Northern Ireland (1996), The Northern Ireland Economic Council (1997) and currently Cooperation North. Substantive issues investigated in association with the Northern Ireland Economic Research Centre, the University of Ulster, the University of Strathclyde and the National Institute of Economic and Social Research include growth and development in the two economies, the long-term economic and social consequences of peace in the island, crossborder shopping and the economic and policy impacts of EMU. In the period since 1991, this programme of comparative research has not only been innovative but also strategic in view of the growing sense of co-operation between the two parts of the island of Ireland.

Collaboration at International Level: Since 1973, when Ireland joined the European Community, the Institute has undertaken a growing number of research projects and surveys on behalf of the Commission of the European Communities. Such direct involvement provides an EU dimension to the work of the Institute in the development of research activity and the evaluation of international trends. Areas in which the Institute has played a co-ordinating or participatory role include:

- the effects of the Single European Market (SEM) and the Community Support Framework (CSF) on the economies of Ireland and other peripheral countries, including the development of economic models for these countries;
- industrial policy in peripheral countries;
- the development of small and medium sized industries (SMEs) throughout the EU;
- the labour market, vocational training issues, transitions from education to work and the integration of young people;
- social policy issues such as income distribution and social protection, integration of the socially less favoured, minimum adequate income, the funding and administration of health services etc.

Increasingly, the research staff of the Institute are involved in European-wide networks organised under the aegis of the Commission. This direct participation in the activities of the EU ensures a valuable two-way flow of information. On the one hand, this research is frequently drawn on by the EU in making future policy and it is very advantageous for Ireland to have an input at an early stage, so giving early expression to Irish concerns. On the other hand, participation in these studies provides a return flow to Ireland of detailed information about the EU and its future priorities.

developed working The Institute has relationships with other international organisations such as the Organisation for Economic Co-operation and Development (OECD) and the World Bank. Substantial collaboration also occurs with leading universities and research institutes in other countries.

#### **COUNCIL CHANGES**

During 1998 Mr K. Bonner, Mr P. O'Reilly, Dr M. Somers and Mr C. Storm retired from the Council. Professor P. Geary, Mr P. Haran, Ms P. O'Donovan and Mr. E. Sullivan were elected to the Council.
